5. Do you have any other comments / suggestions about what the Local Plan should contain?

We refer to our response in January 2020 to the 'Direction of Travel' consultation on 'Issues and Options' in which we said "secure further suitable land for housing development by identifying in collaboration with the neighbouring authorities of Lewes and Wealden District Councils a suitable location for a new sustainable garden community between Lewes and Uckfield to be served by a new rail link between those two existing market towns and linked directly with Eastbourne, in collaboration with MHCLG, DfT, Network Rail, Transport for the South East, and East Sussex County Council."

We wish to reiterate that observation in light of Transport for the South East's more recent Strategic Investment Plan which identifies a new rail link between Lewes and Uckfield as a project to be taken forward. Although Lewes District is not an adjoining authority as Wealden District is, it is in a sense joined through 'shared services' arrangements and so we hope that there would be conversations about a shared approach to meeting the challenges and opportunities of growth as Eastbourne grapples with pressures which it cannot accommodate within its own borders. We are already closely engaged with Lewes District's evolving Local Plan process.

Accommodating some of Eastbourne's housing growth pressure in Lewes District, for example at Ringmer (outside the South Downs National Park), could be persuasive in helping make the strategic business case for a Lewes-Uckfield rail link and arranged to include an Eastbourne-facing connection putting Ringmer only 25 minutes away by rail, with onward linkages northwards beyond Uckfield.

As shown under Question 1, Railfuture has a strategic interest in the Local Plan overall and would welcome any opportunities to make suggestions as the structure and content of the Local Plan start to take shape.
