On 12th May 1986 Kensington Olympia services were NOT extended to and from Willesden Junction station, just Willesden as the place for through services to connect in and out of the West Coast Main Line. Scheduled West London Line Silverlink Metro passenger services from Clapham Junction via Kensington Olympia first reached Willesden Junction station on Tuesday 31st May 1994. Thanks, Stuart G.


A clarification: in the previous, May edition we said "One thing which we shall <u>not</u> be doing is engaging with the Public Inquiry for unresolved objections to the application for a Transport & Works Act Order for Robertsbridge Junction-Bodiam, which had been due to start on 26 May but has been postponed sine diem." That was only in the context of the Inquiry's indefinite postponement, not a change from our position of support for the Robertsbridge – Bodiam proposal.
