'Short-sighted rail companies shooting themselves in the foot'

You may have seen this press release from Railfuture nationally, criticising plans to cut rail services to save money: https://www.railfuture.org.uk/Press-release-26th-August-2021?platform=hootsuite.

Though it is obvious that the railway has suffered a massive loss of business during the pandemic, and needs to cut its net costs, simple timetable cutbacks are not the best answer. Winning the business back, albeit recognising that the traditional weekday peak has almost certainly gone forever, is much the better way. Let's not forget that as the pandemic eventually eases, climate change will resume its place at the top of the political agenda. Rail is well placed to help the country to tackle that. Worth a letter to your MP?

And finally - electrified motorways?

The DfT has awarded £20m for research into 'zero emission road freight'. Part of this is the 'Electric Road System' trial, led by Costain Ltd, for possible overhead wiring for a 30km stretch of the M180 motorway near Scunthorpe. I know that isn't within our Branch area, but I still thought it worth a mention.

Trolleybuses carrying goods! Given that the proposed test installation is in North Lincolnshire, did they get the idea from the Trolleybus Museum at Sandtoft https://www.sandtoft.org.uk? I would imagine that, with pantographs rather than trolley poles, a twin-wire system as depicted would require some extremely accurate lane discipline...

While there may be value in doing such things (well, possibly...), I would suggest overhead-wiring of the railways is rather more tried and tested. Coupled with modal shift, it would achieve vastly more in terms of transport decarbonisation.
