Bid to home asylum seekers in seafront hotel divides town

» NORTH Devon residents have been left divided over plans to house asylum seekers in an Ilfracombe hotel.

It was announced last week the Home Office plans to house people at the Dilkhusa Hotel while they wait for a decision on their asylum application.

Cllr David Worden, leader of North Devon Council, said they became aware of the plans through local knowledge, and were only approached by the Home Office on October 4 to confirm the hotel's inclusion in the Asylum Dispersal Scheme. He said the council will make every argument to convince the Home Office the town is not suitable for the scheme.

Some residents believe Ilfracombe to be unsuitable for refugees due to the current lack of housing and deprivation in the town.

One local said: "We don't have the infrastructure to look after these people. Our town is at capacity, with so many of its locals already homeless. Schools are full, doctors and dentists are stretched thin. It's just not viable for our tiny town to take on an extra 500 people."

Another added: "We cannot cope at present with how North Devon has increased its population. This will make it even worse."

But one commenter said: "People waiting for housing are looking for permanent homes, not small hotel rooms."

Cllr Terry Elliot, Housing Champion for Ilfracombe Town Council, said: "It's amazing how many neonle are flagging up the

Bideford rail line project gets boost with GWR funds

A PROJECT to develop the case for an extension and upgrade of the Tarka Line has received a £6,500 grant from Great Western Railway.

The Tarka Rail Association successfully applied for a grant from the train operator's Community Fund, which was launched in May to support local communities and address areas of social need.

The Atlantic Coast-Exeter Railway project, ACE Rail, aims to give Bideford a boost by extending the Tarka Line to the growing town's 30,000

also by improving the existing line to add a second, limited-stop, hourly Central in 60 minutes.

First step is an initial business case next March. to present why the Tarka line should be extended and further work would look at where stations would be and how it would be funded.

Mike Day said: "We're extremely grateful for this funding from Great Western Railway, which has helped of stakeholder and public support to
