



# Rail User Group Awards 2013

## Rewarding Rail User Groups

*Let the oxygen of publicity breathe fresh life into your campaigning for railway development!*

Prizes will be presented at Railfuture's November conference, in Oxford this year, as they were in Birmingham last year. The second Rail Users Group Awards will again aim to recognise and reward the various achievements over the past year among the country's 300 RUGs in fulfilling Railfuture's mission: to be the number one advocate for the railway and rail users.

For some general clues to what's involved you can do no better than draw on last year's experience. *Railwatch* issue no.132 for July 2012 introduced last year's inaugural RUG Awards on pages 16-17, and the *Railwatch* issue no.134 for December 2012 covered the outcome. The award categories for 2013 are:

- 1 - Best newsletter - Gold and Silver awards [not available to last year's winners]
- 2 - Most improved newsletter - available exclusively to all 2012 entrants
- 3 - Best website - Gold and Silver awards [not available to last year's winners]
- 4 - Most improved website - available exclusively to all 2012 entrants
- 5 - Most effective campaign in 2013
- 6 - Most effective 2013 new group
- 7 - Most outstanding individual RUG campaigner in 2013 [Railfuture members only]
- 8 - Judges' Special Award

***The closing date for your submissions is 23.59 on Monday 30th September 2013.***

There are no application forms. Just one nomination in each category will be sufficient for the nominated **newsletter, website, campaign, new group** or **individual** to be considered; as last year these awards will not be decided by popular vote but on merit by a panel of judges. The same person or group can nominate in more than one category. RUGs and individuals can nominate their own **newsletter, website, campaign** or **new group** as well as others; there will be no personal self-nomination accepted in the seventh category! The **Special Award** is reserved to the sole discretion of the judging panel, which as last year we plan to include our Vice-Presidents.

For **best newsletter** or **most improved newsletter**, please confirm your wish to be considered for the award by sending an email to [roger.blake@railfuture.org.uk](mailto:roger.blake@railfuture.org.uk) or a letter and in either case post a paper copy of your latest and up to the three other most recent newsletters to...

Please do NOT email the newsletters themselves otherwise you will overload Roger's inbox!

For **best website** and **most improved website**, which will be judged at any time during October, again please send an email or letter confirming your entry, with a link to your website, to Roger Blake as above.

For **most effective campaign in 2013**, **most effective 2013 new group**, and **most outstanding individual RUG campaigner**, please email or post your nominations to Roger with your submissions of up to 200 words each. A limited selection of supporting evidence can be sent to him by post, or by email if just plain text.

*A lesson from last year:* Roger strongly advises the use of tough envelopes for postal submissions, and the use of Recorded Delivery.

All submissions must please:

- identify the individual making the nomination,
- indicate whether the nomination is personal or on behalf of a named group and if so in any particular capacity,
- include a full postal address and at least one telephone number where possible.

The intention is that these awards are open to Railfuture members and \*RUGs affiliated to Railfuture, with eligibility to entry being one of the benefits of membership. However, we recognise that many currently non-affiliated groups and their members do sterling work in a wide variety of ways which should not be allowed to pass unremarked. Such groups should nevertheless be able to enter the Awards competition by identifying at least one currently-subscribing Railfuture member, by membership number or postcode.

The national website [www.railfuture.org.uk](http://www.railfuture.org.uk) has details of how to join Railfuture, including online payment using Paypal. As in the inaugural year, the prizes will include a year's subscription to Railfuture, so that will be a 'free introductory offer' for non-member RUGs whom we trust will then renew their affiliation a year later.

All nominees must have their current membership status (individual or affiliated RUG) indicated together with date of expiry of any current subscription, and if 'none' then confirmation of a wish to apply for individual or RUG membership if a prize-winner. Railfuture wishes to be inclusive and while membership is at the ultimate discretion of the Board of Directors, it is very rarely withheld.

With apologies for all the terms and conditions (at least not in unreadable small print!), please feel free to raise any queries with Roger Blake as above. There's more time this year to make your preparations for nominating. May Oxford be as awarding an experience as it was for several who came to Birmingham!

And finally, book now at [www.railfuture.org.uk/conferences](http://www.railfuture.org.uk/conferences) to benefit from the Railfuture members' early-bird-discounted Oxford conference fee of just £25 (includes lunch and conference report). Be there to collect your RUG Award, have the occasion photographed for your own local publicity, and have the further opportunity available only to conference participants to earn yourself a prize for correctly guessing one of the Award winners.
