As I am classified as disabled I hold a National Rail Disabled Persons Railcard (34% discount on rail fares) and (from 18 June 2014) a London Freedom Pass giving me free travel on buses, tube, tram, DLR and Overground/national rail within London (and which also functions as a English National Concessionary bus pass outside London). So no local public transport fares are shown after 18 June unless not covered by concessions.

I aim to keep all of my official expenditure to the absolute minimum. I do not claim the internet allowance, nor do I claim for any postage or telephone costs (mobile or fixed line) – I do spend a lot of time on the phone on Railfuture business both internal and external. I do all my own photocopying and printing at home for which no costs whatsoever are claimed.
