Not being constrained by known existing and currently-planned rail infrastructure, but anticipating the opportunities for new developments in areas which have reasonable prospects of new rail infrastructure in the medium-longer-term eg The Windrush Line in West Oxfordshire supporting growth at Eynsham / Salt Cross, Witney and Carterton, and in West Suffolk at Haverhill via South Cambridgeshire.
