1. Personal Statement

With one exception the only items for which I have claimed relate to travel to meetings of the Board of Directors, (four standard and one emergency). My travel claims are relatively large because of my geographical location, but in each case I minimised the amount both by obtaining cheap advance fares and getting a one-third reduction by use of my Senior Railcard for the rail part of each journey. (I have a 40-mile drive to the nearest mainline railhead, essential if overnight stays are to be avoided.) I also waived £10 of each claim.
