ANNUAL GENERAL MEETING 2015

The 11th Annual General Meeting of the Railway Development Society Limited will be held at

Savoy Hotel, Queens Promenade, Blackpool, Lancashire, FY2 9SJ on Saturday 16th May 2015, starting at 11.00 am (registration from 10.00 am onwards)

On foot from Blackpool North Railway station (25 minutes): Leave the station by the main entrance and take the walk up the slope going to the right by red brick wall (don't take the subway) bearing round to the left. Turn right onto High Street walk approx 400m then turn right onto Pleasant Street, walk approx 20m to the mini roundabout, take the first left onto Egerton Road. Egerton Road bears round to the left, follow this for approx 600m until the T junction with Carshalton Road where you turn left. Walk approx 20m then turn right onto Dickson Road. Follow this for approx 500m as it slowly curves to the left. You'll reach a large roundabout with the Gynn pub just before it on the right, take the second exit onto Queens Promenade and the Savoy Hotel is the large redbrick building on your right.

By tram: Sadly the tram is not yet direct from Blackpool North, its a little walk to the sea front to join it. Leave Blackpool North by the main entrance, take the subway under the road then turn left up the slope, turn right at the top onto Talbot Road. Follow this all the way to the seafront then turn right, where you will find the North Pier tram stop just on your left across the road. You need to get a tram just three stops to Gynn Square, where the hotel will be just across the road.

By bus. Follow the same route as the tram under the subway, walk down Talbot Road, turn right onto Dickson Road, the stop is about 100m along, outside 'Funny Girls,' they run about **every 10 minutes, Number 3** towards **Cleveleys Park** and **Number 4** towards **Cleveleys Centre**, ask for Gynn Gardens, the bus stops by the side of the hotel.

They should be posted in typed format or emailed to lloyd.butler@railfuture.org.uk. For legal reasons motions sent to a different recipient cannot be considered.

Amendments to motions should be sent in writing or by email, with proposer's and seconder's name, before the day of the meeting. At the Chairman's discretion, further written amendments may be accepted by 12.30 on the day. You should also check the policy folders on our website, which set out our existing policies.

The Chairman has the right to send, before the meeting, copies of any motion(s) to any Branch, Directorate, Group or officer whose work it may affect. This is purely to ensure well-informed discussion at the meeting.

Motions on local issues should normally be debated at Branch AGMs but may also, in exceptional cases, be put to the National AGM. Emergency motions may be put to the meeting at the Chairman's discretion.

Motions should be CONCISE (preferably not more than 100 words). A motion will <u>only</u> be considered if the proposer or seconder attends the AGM in person to speak on them and/or answer questions. Motions without a seconder will not be accepted. Any member proposing two or more motions must indicate order of priority (motions other than his/her first one will only be put if time allows).
